## Sudan: Visa Options for Bangladeshi Nationals

There is no Sudanese Embassy in Dhaka, Bangladesh. Sudanese Embassy in India does not process visa for Bangladeshi passport holders. An applicant must apply to nearest Embassy which in Pakistan.

**Visa Regulations of the Republic of the Sudan**

1. The applicants must submit two visa application forms duly filled and attach a passport size recent photograph on each of them.
2. The passport of the application should be valid for at least six months from the date of application.
3. Visa fee in favour of Embassy of Sudan, Islamabad, Pakistan.
4. The sponsor you intent to visit in the Sudan should obtain approval from the Ministry of Interior and then send it to the Ministry of External Affairs of the Sudan, who in turn will fax the same direct to the Embassy.
5. A confirmed return ticket to and from Sudan.
6. In case of a business visa, the applicant should submit a letter from the Chamber of Commerce of the state of the applicant.
7. The Embassy of the Sudan issues only single entry visas to applicants.

**Entry permit application (initial airport)**

- Writing the name in English or according to the name on the passport.

- Place and date of birth must be committed by day, month and year.
- Occupation gender (male ,female)
- Determine the type of document (normal, diplomatic, emergency travel document ... others)

- Accompaniments (copy of the passport, pledge of the guarantor, approval of the Labor Office in case of work, approval of educational institutions ... Zalakh).

#### **Liabilities depending on the reason for entry**

- Work (permission for initial work).
- Official assignment (letter from the government agency requesting the visit or from the Ministry of Foreign Affairs).
- A voluntary organization (letter from the Humanitarian Aid Commission).
- Investment (letter from the Ministry of Investment).
- Study (university speech and higher education).
- Tourism (letter of the Ministry of Tourism and Wildlife).
- Treatment (treatment institution letter).
- A visit (for the purpose of first-degree relatives).

#### **Requirements for granting entry permit permission**

- Submission is through the guarantor. (Company, institution, personal, ....).
- A letter specifying the purpose of entry with a letterhead of the company or a regular handwritten request in cases of a personal guarantor.
- Attach the required supporting documents for the purpose of entry and a copy of the passport.
- Attach documents of the company or institution or proof of identity for a natural person.

- A letter of authorization for the delegate or his identity.

### **Foreigners registration application**

- Place and date of issuance of the passport.

- Place and date of entry to Sudan.
- The number and destination for issuing the entry visa.

**Requirements for granting the card**

- Obtain the Sudanese nationality by birth.
- Foreign passport I will see effect.
- Parent consent for children under 18 years of age.
- Photo.
- Blood type .
- Attendance of the applicant in person.

**Requirements for granting all kinds of residency for the first time or renewing it**

- Show a valid foreign passport.
- Entry in a legal form (entry visa + arrival stamp through an official port).
- The full address of the guarantor is in Sudan
- If you have relatives in Sudan, mention them (name, address).
- The challenge of the purpose hurt, for which I entered Sudan
- A valid work card (residence for work).
- A letter of higher education, university, and international student (residency for study).
- Investment letter (residency for investment)
- Residence for marriage (notarized marriage certificate and any birth certificates for children

**Request a visa, exit and return**

#### **Requirements for granting exit and re-entry visas**

- It is granted to a foreigner who obtained valid residency (annual, regular, and special) for the purpose of leaving the country and returning to it again.
- Guarantor request + authorization. Attach the necessary documents.
- Attach the letter and documents of legal personality and a letter of authorization for a representative, and his identity in the case of a natural personality
- Show the vacancy of the personal tax party in cases of residence for the purpose of work
- It is granted to the investor after showing the investment letter
- Guarantor approval (in cases of marriage) and his personal presence
- In the case of children of Sudanese origin, the consent of the parent or guardian is required
- Accompanying persons with residency are taken into consideration when submitting the application

#### **He required an exit visa to temporarily leave the country**

- Writing the full name according to the passport language
- Passport number, place and date of issue
- Its validity period
- The intended party
- The guarantor is from Sudan
- The guarantor address is complete in Sudan
- The purpose of travel

#### **Exit visa requirements to temporarily leave the country**

- Granted to foreigners in cases of serialization (the serial person is a foreigner who entered the country illegally, whether without an entry visa or entry visa through an official port or transit)

- Through an official port without obtaining an entry visa, except for the nationalities that are allowed to enter the country without an entry visa).
- Review the passport and its validity.
- A surveillance investigation request around the country
- Attendance of a Sudanese guarantee (legal or natural person)
- Submit an application and undertaking from the guarantor and attach proof of identity
- Pay a fine of (3) month

### **Final exit visa application**

- Writing the full name according to the passport language.
- Passport number, place and date of issue.
- Its validity period.
- The intended party
- Guarantor in Sudan.
- The guarantor address is complete in Sudan
- The purpose of travel

### **Exit visa requirements to temporarily leave the country**

- Granting of residency to foreigners (local, annual, regular, for the purpose of permanently leaving the country)
- All exit and return controls and procedures are followed
- The residence is cancelled
- Review the passport and its validity

### **Remember the pass**

- Writing the full name according to the passport language.
- It is issued by a document from the Foreigners Department in the event that the passport is expired or lost and there is no foreign embassy in Sudan.



- The computer is reviewed in case the passport is lost and the previous passport transactions are reviewed to determine the guarantor, fines, taxes and any other obligations.
- The ticket period is two months, and it is used for an oasis travel only for the purpose of leaving to his country
- Guarantor in Sudan.
